LIVE COVER Breeding Contract

This breeding contract is made and entered into as of this _____ day of _____, _____ for the 2019 breeding season.

I have, hereby, contracted Live Cover Stud services for my mare: _____

- 1. Mare Owner agrees to pay a breeding fee of \$500.00. Of that amount, a \$50.00 non-refundable booking fee shall be due with this contract. All fees (with the exception of mare care) shall be paid in full BEFORE any services are rendered. A MULTIPLE MARE DISCOUNT OF 10% WILL BE APPLIED.**
- Mare care will be charged at a rate of \$15 per day (DRY mare) OR \$20 per day (WET mare with foal). Mare care must be paid in full before the mare may be picked up from the facility.
- Mare Owner represents that the Mare is in sound breeding condition and free from any disease or infection. Stallion Owner recommends a veterinary examination for sound breeding condition. A current negative Coggins must be provided upon the Mare's arrival at the facility. The Mare Owner also represents that the mare is halter broke.
- In the event the Stallion becomes unavailable for breeding due to death, injury, illness, or infertility, the Mare Owner shall have the option of (1) cancelling this contract and the Stallion Owner will refund the breeding fee, less the non-refundable deposit, OR (2) the Mare Owner may request breeding to another stallion owned by the Stallion Owner as agreed upon by both parties.
- LIVE FOAL GUARANTEE:** The Stallion Owner guarantees one "Live Foal" during the breeding season. The term "Live Foal" means a foal that will stand and nurse without assistance. In the event that the Mare does not deliver a "Live Foal" during the breeding season, then the Mare Owner shall be entitled to one additional re-breed to the same Stallion.
- Mare Owner agrees to have the mare pregnancy checked no later than 18 days after her last breeding date, and notify the Stallion Owner of the results no later than 30 days after her last breeding date. If the Mare is left at Cofer Ranch for pregnancy checking, this will be done at the Mare Owner's expense.

7. Mare Owner understands that engaging in equine activities, including breeding a mare, is an inherently dangerous activity and that by doing so, the Mare is exposed to dangers both known and unknown including illness, injury, disease, or death. Mare Owner agrees to hold harmless Stallion Owner, Cofer Ranch, and its employees against any and all claims.
8. In the event of injury or emergency, the Mare Owner gives the Stallion Owner permission to treat the Mare at the Mare Owner's expense. The Stallion Owner will first try to contact the Mare Owner using the contact information provided.
9. A breeder's certificate will be issued to the Mare Owner after all fees and expenses have been paid in FULL and upon notification of birth of a live foal.
10. Mare Owner agrees not to assign or transfer this contract without prior written consent from the Stallion Owner.
